#### 4.1 Public Question Time

#### Nick Brain on behalf of Better Deal Whittlesea

Can Council explain how its community plan will help give residents a better deal and restore their community's liveability?

#### **Chief Executive Officer, Craig Lloyd**

The Community Plan 2025–29 is designed to support everyone across the City of Whittlesea, regardless of background or stage of life. It focuses on enabling communities to live well, through a four-year strategy structured around 12 key themes. These themes cover a broad spectrum of community life, including safety and connection, transport improvements, enjoyment of the natural environment, and full participation in community culture and activities.

We heard from community what their priorities are and have responded with 55 Strategic Priorities above the ongoing work and services already provided by Council.

To deliver on the Community Plan 2025-29 we have shaped 46 targeted actions, services and projects, as detailed in the Community Action Plan for 2025-26 to help address these priorities in meaningful, practical and sustainable ways.

Should Council adopt the Community Plan tonight, it will be available on Council's website.

#### **Daniel Meissner of Wollert**

Can you tell us what we can look forward to in Wollert?

#### Chief Executive Officer, Craig Lloyd

Each year Council delivers a range of projects and programs right across the City of Whittlesea, including in Wollert.

We have recently completed an extension to Baltrum Drive, installed traffic management and lighting along Macedon Parade and Wyperfield Way and completed the Allumba Off-Leash Dog Park.

Construction is in progress of the West Wollert Community Centre, we are designing the Edgars Creek Sports Reserve ready to build and planning for the Central Wollert Sports Reserve. Wollert Central Kinder is being completed as well as Maternal and Child Health consulting rooms at Early Learning Victoria Umarkoo Centre. Duplication of De Rossi Boulevard (between Belknap Street and Epping Road) was also recently completed.



Council will also spend more than \$500,000 next year on renewing several local roads including Bodycoats, Boundary and Summerhill roads.

Next year construction will commence at Cerridwen Park and a roundabout at Crescendo Boulevard/Bellavista Drive/The Parade intersection in Wollert.



#### **Extension of Speaking Time**

The Mayor, Cr Taylor exercised his discretion to extend the speaking time for officers to present their report for up to five minutes in accordance with Governance Rule 35.5.

#### **Executive Summary**

The Community Plan 2025–29 (Attachment 1) is a comprehensive four-year strategy designed to support everyone across the City of Whittlesea—regardless of background or stage of life. Grounded in local feedback and community insights, the Plan is structured around 12 key themes that reflect the broad spectrum of community life, including safety and connection, accessible transport, enjoyment of the natural environment, and full participation in local culture, services and activities.

Over the past six weeks, Council has actively consulted with our community on the draft Community Plan 2025–29 (CP), which also incorporates the Municipal Public Health and Wellbeing Plan (MPHWP), Disability Action Plan (DAP), and the Community Action Plan 2025–26 (CAP). This consultation period was a vital opportunity to showcase how early community input, gathered in late 2024, has directly shaped the Draft Community Plan and its accompanying first-year action plan.

A total of 370 community members participated in this final round of consultation, building on the contributions of more than 4,500 voices across all engagement phases. This strong involvement demonstrates a high level of community confidence in the direction and priorities of both plans, with:

- 88% of participants supporting the Community Plan 2025–29.
- 89% supporting the Community Action Plan 2025–26.

These results clearly show alignment between the 55 Strategic Priorities outlined in the Plan and the values and aspirations expressed by the community throughout the consultation process.



Across the full four phases of engagement, we:

- Hosted 35 community pop-up sessions (with thanks to the Mayor and Councillors who joined some of these events);
- Delivered 3 Key stakeholder presentations;
- Facilitated 4 focus group sessions with 66 participants;
- Received 877 digital contributions; and
- Collected 790 in-person contributions.

Council also ran 15 workshops with Community Health Partners, representing 11 local organisations, to help inform the priorities for both the Municipal Public Health and Wellbeing Plan and the Disability Action Plan.


As detailed in the Engagement Summary, the consultation process achieved broad representation, with participants from across 15 suburbs, a wide range of age groups, a balanced gender mix, and 97% of responses coming from people who live in the City of Whittlesea.

In direct response to community feedback, the Plan addresses critical issues such as violence prevention, physical and mental wellbeing, homelessness, housing affordability, waste management, and employment and participation barriers. The Plan also commits to delivering tangible improvements like safer roads, enhanced transport options, welcoming parks and community spaces, and more accessible community facilities.

In parallel with community engagement, a number of workshops were held with Council throughout the development of the Plan. These sessions provided opportunities for the Council to explore key themes, review emerging priorities, and ensure that the Plan aligns with the City of Whittlesea's long-term vision. The input and guidance from Councillors have been instrumental in shaping a Plan that reflects both community aspirations and strategic leadership.

To translate the vision into action, the Community Action Plan 2025–26 (Attachment 2) sets out 46 targeted initiatives for delivery in the first year. These initiatives have been designed to address the community's top priorities in a meaningful, practical and sustainable way.

Together, the Community Plan and Action Plan create a clear roadmap aligned with Whittlesea 2040, guiding Council's work and our partnerships with the community over the next four years and ensuring we stay transparent and accountable as we deliver on what matters most to our residents.



We extend thanks to everyone who participated in the yearlong engagement journey. Your feedback and ideas have helped shape a Community Plan that is inclusive, practical and future-focused.

# 5.3 Planning Scheme Amendment C280 - Update to Existing Heritage Overlay - Request for Authorisation

**Director/Executive Manager:** Director Planning & Development

#### **Executive Summary**


This report presents proposed Planning Scheme Amendment C280wsea – Heritage Overlay (Amendment C280wsea), which seeks to update the Whittlesea Planning Scheme (Planning Scheme) in relation to 73 heritage places that are already listed in the Heritage Overlay.

Heritage places play a vital role in the City of Whittlesea. They strengthen community identity and foster a strong sense of place by providing meaningful, tangible links to the past and people.

Places of local heritage significance are protected by the Heritage Overlay (Clause 43.01) in the Planning Scheme. The Schedule to the Heritage Overlay in the Planning Scheme lists all the places of local heritage significance in Whittlesea. Currently there are 173 heritage places protected under the Heritage Overlay in the Whittlesea Planning Scheme including farm complexes, churches and cemeteries, schools, bridges, commercial buildings, houses and homesteads.

The Heritage Overlay protects local heritage places by preserving their cultural and historical value, enriching the community's identity, and ensuring that future generations can enjoy and learn from these important sites. The planning controls require a planning permit to carry out works on a listed heritage place.

In 2021, a gap analysis of heritage places on the Heritage Overlay was undertaken and listed places that required additional or updated heritage citations and Statement of Significance were identified. An external grant was obtained, and heritage consultant David Helms Heritage Planning was engaged to prepare the Whittlesea HO Places Review, Volume 1 and Volume 2 (Helms Heritage Places Review, see Attachment 1). The Helms Heritage Places Review provides more accurate and rich information in relation to significance of 66 heritage places already listed in the Heritage Overlay.



Having more comprehensive and accurate information and data provides for a clearer framework to make well-informed decisions about development proposals and permit applications. This will streamline the assessment of permit applications, provide more clarity for developers and property owners, improve the quality of information Council receives from heritage advisers and support design responses that respond effectively to heritage values, as part of future development proposals.

Amendment C280wsea proposes to implement recommendations of the Helms *Heritage Places Review* and update the information contained in the Whittlesea Planning Scheme in relation to the 66 existing heritage places. Administrative updates to the Heritage Overlay Schedule have also been made to a further seven existing heritage places. In total, 73 existing heritage places are affected by the Amendment which will provide enhanced protection to the significance of these places. No new places are proposed to be added to the Heritage Overlay as part of this Amendment process.

This report recommends that Council resolve to commence Amendment C280wsea and seek authorisation from the Minister for Planning to prepare and exhibit the Amendment. Following authorisation from the Minister for Planning, the Amendment will be publicly exhibited to the community. Individual affected property owners and occupiers will be contacted through a consultation process. The outcomes of the public exhibition and consultation process will be subsequently reported back to Council as part of a future report.

The Amendment will ensure that more comprehensive information about the significance of existing heritage places is included in the Whittlesea Planning Scheme to enhance the protection and conservation of these significant places for the Whittlesea community into the future.



#### 8.2 Chief Executive Officer, Craig Lloyd Update

#### **McDonalds Road Bicycle Paths**

Construction is well underway on the new bicycle path along McDonalds Road. The 900-metre path runs from Scarborough Road through to the E6 Reserve, connecting Epping to Westfield Plenty Valley. We're also improving safety for cyclists and pedestrians with the addition of three new raised crossings at Scarborough, Derby and Cabot Drives in Epping.

#### **Stables Kindergarten Redevelopment**

The redevelopment of the Stables Kindergarten in Mill Park is progressing well with demolition of the old building complete and concrete foundations now going in. The kinder is temporarily operating from the Mill Park Drive Children's Centre while works are underway.

#### **Public Lighting in Local Streets**

We're continuing to invest in improving public lighting across local streets, so residents feel safer after dark. Recent upgrades have been completed in Thomastown, Lalor and Doreen, with more to come in Lalor, Epping, Doreen and Whittlesea. Depending on the location, works include everything from new bulbs and poles to completely new installations. It's a practical way we're improving everyday safety in our neighbourhoods.

#### **WI-FI Access at Community Facilities**

We've also rolled out free public Wi-Fi at a number of community facilities to make it easier for people to stay connected when they visit. The upgrade means faster, more reliable internet in offices, meeting rooms and shared spaces. Sites now online include Miller, Janefield and Spring Street community centres, as well as Nick Ascenzo, May Road, RGC Cook, Wollert, Painted Hills, Epping and Olivine.
