

Councillor Expenses

The Local Government Act 2020 requires Council to reimburse Councillors for expenses incurred whilst performing their duties. Council is also required to adopt and maintain a Policy in relation to the reimbursement of expenses for Councillors, and a Policy was adopted by Council under Section 41 of the Local Government Act 2020 on 16 July 2024. The Councillor Expense and Support Policy provides guidance for the payment of reimbursements of expenses and the provision of resources, facilities and other support to the Council to enable them to discharge their duties. Council publishes the details of the expenses, including Councillor reimbursements, in its Annual Report.
