- The event must be a local educational, cultural, political, religious, social or recreational event not held for commercial purposes.
- Community groups are only allowed temporary signage on Council land once in any six month period.
- Wording and graphics on the sign may not be indecent, insulting or offensive.

Placement and dimensions of sign

- You may nominate up to three of the specified sites listed on the page above, plus the site of the event if appropriate. Please number in order your preferred sites.
- There may only be two sign boards installed per any parcel of land at any one time.
- Event partner logos must not cover more than 10% of the sign.
- The sign must not be more than five square metres in area, and no part of the sign may be higher than three metres above ground level.
- The sign, when approved, must not be displayed longer than four weeks prior to the event and must be removed within seven days of the conclusion of the event.
- The sign must be of sound construction with no protrusions.
- The sign cannot be animated or illuminated.
- The sign must be installed only in the approved park within designated area shown on the map which will be supplied to applicants.
- Signs left on display after the date on the application will be removed at the event organiser's expense.

Other

 Applications will be considered for parks not included on this list where the event is held in that particular park.

Lodgement of this form does not automatically grant permission to display a sign. City of Whittlesea will notify applicant in writing to confirm approval.
